WHEREAS, Lloyd Jones, Reva Jones Boyd, Lillie Mae Crawford and Charlie Eldridge claimed fee simple title to lands hereinafter described condemned pursuant to the petition and prayer of the City of Huntsville and Madison County in Cause No. 14431 of the Madison County Probate Court and are now claiming the proceeds from the taking of the following described property lying in Madison County, Alabama, to-wit:

NOW THEREFORE, it is ORDERED that publication be made in the Huntsville Times once a week for four consecutive weeks requiring any party or parties who may claim to own any right, title or interest in or hold any lien against the property above described, including the unknown heirs of Neal Collier, to answer, plead or demur to the bill of complaint in said cause before the 23 day of 1963, and failing so to do within thirty (30) days after said date, a decree pro confesso be taken against said unknown claimants.
