for the purposes set forth in said petition or application, and the City of Huntsville, a Municipal Corporation, being represented in Court by its Attorney, and it appearing to the court that all interested parties have due and legal notice of the filing of said petition or application and of the day set for the hearing of the same, by personal service upon Charlie Eldridge, Willie Fay Jones, Bethel Jones Hill and George T. Culps, as Tax Collector of Madison County,

Alabama, and by publication in The Huntsville Times, a newspaper of general circulation, in Huntsville, Madison County, Alabama, to Lloyd Jones, Reva Jones Boyd, Lillie Mae Crawford, Neal Collier and Seleste Jones, all of the unknown heirs at law and next of kin of Lizzie Jones, deceased, all of the unknown heirs at law and next of kin of Odell Jones, deceased, all of the unknown heirs at law and next of kin of Haywood Jones, deceased, all of the unknown heirs at law and next of kin of Queen Anne Jordan, deceased, all of the unknown heirs at law and next of kin of Tommie Lee Jones, deceased, all of the unknown heirs at law and next of kin of Emma Blair, deceased and all of the unknown heirs at law and next of kin of Lillie Mae Jones, deceased, together with any other party or parties who may claim to own any right, title or interest in and to, or to hold any lien against the real property and the well situate thereon hereinabove described; and there being present in open court James W. Baker, the said James W. Baker having heretofore been appointed as such guardian ad litem by this Court, and having accepted said appointment in writing, and denying in writing each and every allegation of the petition for condemnation; and also being present in the Court, David R. Archer, as the attorney for Charlie Eldridge, Willie Fay Jones, Lloyd Jones and Reva Jones Boyd, and the other defendants not appearing, the Court now proceeds to hear said petition, together with all evidence touching the same; and

It appearing to the satisfaction of the Court from the allegation of the sworn petition, that the allegation of said petition or application are true; that the above named parties claim or are reputed to claim to own some right, title or interest in or ownership of said lands, and that it is necessary that said real estate and the well situate thereon be condemned for the purpose mentioned in the petition or application: and

It further appearing that no objections have been filed to the granting of said petition and that no objections were made at the hearing.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that said petition or application be, and the same is hereby granted.
