#### **Academic Solicitation**

Defense Counterintelligence Security Agency (DCSA) defines academic solicitation as the use of students, professors, scientists, or researchers as collections improperly attempting to obtain sensitive or classified information.

#### What to Report

Any contact (i.e., emails, telephone, personal contact) that is suspicious because of the manner or subject matter of the request. This may include requests from U.S. persons or from foreign nationals located in the United States or abroad, and may consist of:

- Unsolicited applications or requests for undergraduate, graduate, postgraduate, or other research positions
- Unsolicited requests for access to research papers or other research-related publications or documents
- Unsolicited request for assistance with or review of thesis papers, draft publications, or other research related documents
- Unsolicited invitations to attend and/or present at international conferences
- Unsolicited grants or gifting of funds/equipment to conduct joint research projects from foreign academia institutions or foreign governments

Don't forget your personal social media accounts. I encourage you to use multi-factor authentication for social media accounts and review their privacy settings to make sure they know what information about them is visible online.

Also, please practice smart email hygiene and be on alert for phishing emails. I advise against clicking on suspicious links and/or forwarding questionable information.
